CIRCULAR

Sub: Mazagon Dock Executive Post Retirement Medical Scheme-2014.

In terms of the Clause No. 7.4 of the "**Mazagon Dock Executive Post Retirement Medical Scheme (MDEPRMS)-2014**" notified vide CMD Memorandum No. CH/128/2014 dated 18 Sep' 14, the executives superannuated from MDL after 01.01.2007, who intend to avail medical benefits under this scheme, shall be entitled to expenses towards Out Patient / Domiciliary (OPD). MDEPRM Scheme is uploaded on the MDL website www.mazagondock.gov.in.

2. Anyone desirous to opt for the new scheme needs to contribute a lumpsum amount as notified under at Clause No.6 of the scheme to avail medical benefits as specified under the new scheme. The said amount should be paid in Demand Draft / Pay Order drawn in favour of Mazagon Dock Limited and payable at Mumbai. Prescribed Self-Declaration Form (appended below) duly filled-in should be forwarded alongwith the Demand Draft to SB-HR & ER Dept. by 30.11.2014.

3. Further, it is informed that those executives, who will not opt for availing benefits / ineligible under the new scheme, shall continue to avail medical benefits from MDL Dispensary.

3. However, superannuated executives or executives on rolls, who are not eligible under the above MDEPRMS-2014, will continue to be governed by the existing scheme.

MAZAGON DOCK EXECUTIVES POST RETIREMENT MEDICAL SCHEME-2014

1.0 Title:

The scheme will be known as “*Mazagon Dock Executives Post Retirement Medical Scheme 2014*”. (MEPRMS-2014)

2.0 Objective:

To provide for the medical needs of retired MDL executives and executives who will retire from the services of MDL, as a part of social welfare measure.

3.0 Definition:

MDL means ‘*Mazagon Dock Limited*’ incorporated under the Indian Companies Act, 1956.

4.0 Controlling Authority:

Chairman & Managing Director, Mazagon Dock Limited.

5.0 Eligibility:

The scheme will be applicable to the following categories of personnel:-

- (a) All executives already superannuated from the services of MDL with effect from 01 Jan '07 and have completed 15 years continuous service in Central PSUs including MDL.
- (b) Those executives, who have already retired / will retire under the Pre-mature Retirement scheme on medical grounds and have rendered 15 years continuous service in MDL including services in other Central PSUs, shall also be eligible.
- (c) Executives who die/become permanently disabled and incapacitated, leading to cessation of their service before putting 15 years of continuous service in CPSEs prior to superannuation, will be given the benefit as admissible under this scheme.
- (d) i) The spouse of the deceased executives, who died in harness, shall also be eligible for such medical facility for self on the same terms and conditions as applicable to the retired executives.

- ii) However, the benefit at (i) above, will cease automatically if the dependent surviving spouse is employed elsewhere or is in receipt of medical benefits from any Central PSU or Government/ Government Organization or in the event of his marriage.
- (e) The retired executive will not be eligible to join the scheme, if his spouse or both of them is / are employed in Government / Government Organization / Public Sector Companies and is / are eligible for similar benefits from that organization. Similarly, if the executive and / or his spouse is availing medical facilities from other organizations as part of his post retirement medical benefit like CGHS (as dependant on his son / daughter / daughter-in-law), this scheme will not be applicable to them.
- (f) Physically / Mentally challenged dependent children of an eligible executive will also get medical benefit after retirement.
- (g) The executives, who have retired after 01 Jan '07 under CDA Pay pattern, are also eligible under this scheme.

6.0 Membership Fee:

Any eligible executive, who intends to avail such medical facilities post retirement from MDL, will pay one-time lump-sum contribution in advance at the time of becoming member of the PRMS scheme. The contribution shall be paid prior to his retirement. The contribution shall be as under:-

Sr.	Designation	Lump-sum Contribution (in Rs.)
i)	ED to CMD	7,000/-
ii)	CM to GM	5,000/-
iii)	JE / Junior Executive to Manager	3,000/-

The eligible retired Executives on CDA Pattern who intend to join this scheme will make a one-time lumpsum contribution as applicable to their grade held on retirement.

7.0 Outpatient / Domiciliary Treatment:

- 7.1 The eligible retired executives, who have taken membership, shall be entitled to Outpatient / Domiciliary treatment.
- 7.2 The annual monetary ceilings towards Outpatient / Domiciliary treatment for various grades are as under. The amount so fixed shall be paid in equal installment i.e. in January & July and shall be paid on self certification basis.

Sr.	Designation	Annual Contribution (in Rs.)
i)	ED, Directors & CMD	25,000/-
ii)	CM to GM	20,000/-
iii)	JE / Junior Executive to Manager	15,000/-

This amount will be payable to the executive from FY 2014-15.

7.3 Executives, who retire in between, will be entitled to the above amount on pro-rata basis (To be computed on monthly basis).

7.4 Members availing such outpatient / domiciliary benefits under this scheme shall not be entitled to avail the facility of free medicine from MDL's Dispensary.

8.0 **Indoor Treatment / Hospitalization:**

Indoor Treatment shall be extended to all the eligible retired executives normally through Insurance Company. Detailed modalities shall be decided by a Committee comprising HR, Finance and OTS representatives every year or any reasonable period as mutually decided and agreed with MDL and the Insurance Company.

8.1 **Salient Features:**

The scheme covers hospitalization of expenses up to the annual financial ceiling as prescribed below for the retired executives, his spouse and dependent children as at 5 (f) w.e.f. implementation of the scheme.

ii)	CM to GM	3.00
iii)	JE/Junior Executive to Manager	2.00

* Monetary Ceiling meant for both executives, their spouse and dependent children as at 5(f) on floater basis.

8.2 **Members covered under `Bhavishya Arogya' Scheme:**

Retired Executives including those in service, who are covered under the `Bhavishya Arogya' policy of the Insurance Company shall be covered under the new scheme provided the amount earmarked for each (including his spouse) is consumed. In other words, only if an executive consumes his earmarked amount after his retirement, he will be covered under this

revised scheme. However, his spouse will continue to be under 'Bhavishya Arogya' till the amount specified is fully consumed.

8.3 Executives not completing 15 years service:

The executives who are not meeting the minimum criteria of 15 years continuous service in Central PSUs including MDL shall not be eligible under the existing scheme policy. However, they shall continue to be eligible under the erstwhile scheme / policy.

8.4 Hospitalization facilities admissible referred to in clause 8.0 above will be regulated as under:-

8.4.1 If a retired executive intends to avail treatment in a hospital empanelled by the Insurance company, he can avail the same with cashless facility. In the event of his opting treatment at a non-empanelled hospital, the concerned executive may seek reimbursement from the Insurance Company. The procedures of the Insurance Company for such reimbursement shall be adhered to.

8.4.2 The executive / spouse stationed / located outside Mumbai after his retirement needs to intimate the name of the place of his location and hospital, where he intends to take treatment.

8.4.3 In case of emergency viz. Heart Attack, Accidents Acute Diabetes, Blood Pressure etc. where planned hospitalization is not possible, the concerned retired executive and his spouse may take treatment in any hospital other than as mentioned at 8.4.1 above.

8.4.4 Eligibility for indoor treatment will be restricted to hospital wards / cabins as admissible to the retired executive at the time of retirement.

8.4.5 The annual monetary ceiling for a particular Calendar year is at Clause no. 8.1. Any additional expenses over & above the prescribed monetary ceiling in that year on account of indoor treatment other than the ailments as mentioned at Clause No. 8.4.6 shall be borne by the executive.

8.4.6 The monetary ceiling prescribed under Clause No. 8.1 shall not be applicable in the following ailments which will be considered as 'Special Diseases'.

- (i) Cardiac Procedures and Surgeries
- (ii) Cancer
- (iii) Renal disease
- (iv) Paralysis
- (v) Liver disease

- (vi) Neurological cases of major accidents comprising of head, spinal injuries, complicated multiple fractures requiring implant prosthesis, plating and nailing.

Note:

In the event of any ailment as specified under 'Special Diseases', the expenses shall be met first from the prescribed monetary ceiling as indicated under Clause 8.1 and any amount over and above the monetary ceiling, shall be borne by the Company from the Corpus on submission of medical bills and supporting documents as prescribed.

- 8.4.7 The retired executive may first incur expenditure to take treatment and then submit claims to the office, which will be settled as per the rules.
- 8.4.8. Chemotherapy (cancer) and Dialysis (renal disease) taken at Day Care Centre will be treated as indoor treatment as per clause No. 8.0 of the scheme and regulated accordingly. If any regulation is necessary for such treatment, the same will be notified.
- 8.4.9 No advance will be given to the retired executives for availing Indoor Treatment in respect of these ailments. However, part payment can be considered in deserving cases on case to case basis on submission of supporting documents including medical & hospital bills.
- 8.4.10 No Travelling Allowance either for self or for escort shall be allowed.

8.5 Fund /Corpus allocation towards Special Diseases

A corpus of Rs.1.00 Cr. (Rupees one Crore) is earmarked for reimbursement of medical expenses annual (calendar-wise) for 'Special Diseases' as mentioned at Clause 8.4.6 above on first cum First-cum-First-serve basis. In case fund is exhausted or there is shortfall in the corpus, reimbursement shall be made in the next calendar year out of next year's allocation. If the corpus is not fully utilized, the balance amount will be carried forward to the corpus of the next calendar year. Priority will be given to the pending claims of previous year not settled due to non-availability of funds for settlement in the next calendar year. This may be reviewed every two years by a committee to assess the requirement.

8.6 Physically / Mentally Challenged Child:

- 8.6.1 Employee and /or his spouse covered under 'Bhavishya Arogya Scheme' and having physically / mentally challenged dependent child shall be

entitled to indoor expenses in respect of the said child. The amount shall be incurred out of the corpus created under Para 8.5.

- 8.6.2 In case of demise of one parent (either employee or spouse), the surviving member and their physically / mentally challenged child will be entitled to 100% Outdoor treatment as stipulated under Para 7.
- 8.6.3 In the event of demise of both the parents, the benefit under Indoor Treatment expenses shall be extended to the child till he is alive. However, Outdoor Treatment expenses in this circumstance shall be 50% of the entitlement as specified under Para 7.

GENERAL:

9.0 Medical Card:

- 9.1 HR Department shall issue a Medical Card to the executives after due verification of service details, which shall permit the beneficiary / ies to avail the benefit.
- 9.2 The retired executive / spouse shall nominate one person at the time of becoming a member of the scheme for submitting the claims towards outdoor treatment on behalf of retired executive and or his spouse, in their absence.
- 9.3 The retired executive will provide the Bank account details for the purpose of crediting reimbursement of claims towards out-patient / domiciliary treatment and expenses towards Indoor Treatment as per Clause No. 8.4.6.
- 9.4 The retired executives / spouse will submit a claim in the prescribed form for the pro-rata amount due for the first half yearly payment to HoD (HR), who will arrange to process the same for payment. The subsequent half yearly payment for outpatient / domiciliary treatment i.e. 50% amount of the annual ceiling shall be released directly to the single / own / joint SB Account of the retired executive or spouse or both.
- 9.5 The retired executive / spouse, while submitting the claim in the prescribed form shall mention name of the Bank and Branch, Single / Own / Joint SB Account No. together with a copy of latest self attested passport size photograph.
- 9.6 A system shall be developed by HR in consultation with Finance Deptt. for directly crediting the amount of the concerned retired executive / spouse for releasing payment half yearly for out-patient / domiciliary treatment. Till such time, Account Payee cheque will be issued for disbursement of payment and the same would be sent to the concerned retired executive / spouse by Courier / Registered Post. These claims will normally be settled and payment released within 30 days of submission. Subsequent

installments will be released when due, subject to the conditions stipulated at Clause No. 5.0 of MEPRM Scheme.

10.0 **Procedures:**

10.1 **Submission of Application for Availing Treatment:**

A retired executive or an executive in service, shall prior to his retirement, submit the application in the prescribed format along with two copies of latest passport size colour photographs of self and spouse to HoD (HR), MDL. In case, he intends to avail benefit for his dependent physically / mentally challenged child also, the same should be clearly mentioned along with his passport size photo.

10.2 The application for membership of this scheme should accompany a Demand Draft for the amount as mentioned under Clause No. 6.0 towards Membership fee.

10.3 All retired executives shall submit Life Certificate every year in the month of December in respect of himself as well as his spouse. The Life Certificate may be issued by any one of the following:

- a) Branch Manager of the Bank, any Government or Nationalized Bank where the concerned retired executive / spouse is maintaining a single-owned / joint Savings Bank Account.
- b) A Gazetted Officer of Central / State Government.
- c) Registered Medical Practitioner.
- d) Chief Medical Officer of MDL

10.4 If retired executive / spouse expires during the availing of benefits, the same should immediately be communicated to HR Department and any claim towards out-patient / Domiciliary treatment by the surviving member shall be reduced by 50% of the entitled amount as mentioned at Clause No. 7.0 except the cases covered under Clause 8.6 above and will be paid to him.

10.5 The payment will be made on self certification basis.

11.0 **Forfeiture of Membership:**

In the event of death of the executive or his spouse, the surviving member shall bring the fact to the notice of the Controlling Officer within one month from the date of death.

Non-submission of document / communication shall result in forfeiture of entitlement to the surviving member.

12.0 **Other Conditions:**

12.1 The Company shall not be liable to reimburse any expenses whatsoever incurred by the retired executive in connection with or in respect of

- (a) Venereal disease, psychiatric treatment, intentional self injury, intemperance or the use of intoxicating drugs or liquor or/and injury, disease or illness directly or indirectly attributable to one or more of these causes.
- (b) Charges incurred for diagnostic or X-ray or laboratory examinations or other diagnostic tests not consistent with or incidental to the diagnosis and treatment of any ailment, sickness or injury not prescribed by Authorized Medical Attendant.
- (c) Treatments of congenital defects/disease if these are incurable.
- (d) Expenditure on treatment pertaining to menopause.
- (e) Expenditure on special nursing.
- (f) Expenditure towards cosmetic surgery.
- (g) Travelling expenses or allowance for journey undertaken for the purpose of availing indoor and outdoor treatment.

12.2 MDL has the right to withdraw the facility available under this scheme without any notice, from the retired executives in case it is found that the facilities are being misused.

12.3 MDL reserves the right to amend or withdraw any or all the facilities admissible under this scheme at any point of time without any notice.

12.4 In case of doubt, the same may be referred to HR department for clarification.

* Masculine gender includes feminine also.

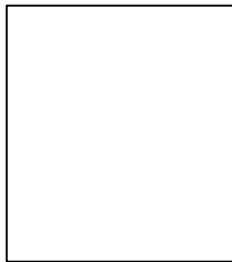

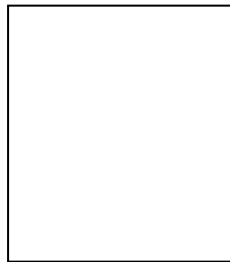

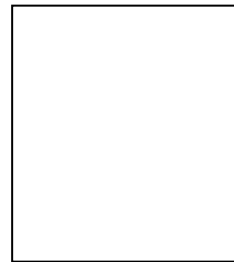
